Thank you for your time on Monday, 2 May, 2022 when we met to discuss what the visit will entail.

Areas

The scope of the visit included the following:

1. Cold water supply, processing and storage, hot water production and distribution, terminal points measurements, records and documentation

Urgent Actions

- 1. A deputy should be appointed to replace in the absence of, and assist the person with overall responsibility for the management of the legionella prevention system. This person must also have been given sufficient training / authority to fulfil their duties. Deputy person has no training no expertise in Legionella management
- Where necessary instruction, information and training should be provided that all involved are capable of conducting their roles in accordance with the requirements of the system. - Roles and responsibilities have not been defined as there is no Legionnaire's disease Control & Prevention manual
- 3. A manual must be established which includes all checkpoints and all actions for treatment and maintenance that must be undertaken to prevent legionaires' disease. There is no Legionnaire's disease Control & Prevention manual
- 4. A maintenance programme must be established which includes all checkpoints, treatment and maintenance to be undertaken to prevent legionaires' disease. There is no planned preventative maintenance programme
- 5. It is important to regularly drain hot water tanks to avoid sediment accumulation. There are no drainage valves at all
- 6. Personnel in charge of maintenance tasks related to Legionnaires Disease Prevention must have suitable knowledgeable and training about that responsibility. Personnel involved have had no training at all
- 7. Laboratory sampling, as a verification tool, should be used to verify that activities and protocols undertaken are effective. No laboratory sampling conducted so far for 2022 season
- 8. Lab analysis and sampling must be carried out at the required frequencies to demonstrate that independent water treatment by the establishment produces water suitable for human consumption. No lab analysis nor sampling conducted so far for 2022 season
- 9. Regular draining will avoid nutrient accumulation in the lower part of hot water tanks which is likely to promote bacterial growth. Hot water tanks are not drained

Recommendation (English)	Legionella pneumophilla dies instantly at 70C, which explains why the application of this protocol, in those facilities where this is possible, is so important.
